# 2024 IMPACT REPORT

Peace at Home Family Shelter is 501(c)3 organization dedicated to supporting and empowering survivors of domestic violence so they can succeed in every part of their lives. We provide shelter, services, and support to women, men, children, and any person fleeing domestic violence in Northwest Arkansas.

### **OUR MISSION**

Our mission is to empower survivors of domestic violence to survive and thrive by nurturing their self-determination and courage; and to promote healthy relationships and compassionate communities through education, outreach, and advocacy.

### **OUR HISTORY**

Peace at Home was founded in 1977 as the first domestic violence shelter established in Arkansas by community members who sheltered survivors in their own homes.



# YEAR IN REVIEW

As we reflect on 2024, we are grateful for the steady support of our community. With your help, we were able to provide a total of 9,359 nights of safe shelter for families escaping domestic violence. This year has been one of significant growth and accomplishment for Peace at Home Family Shelter, including:

- The opening and immediate use of the Candy Clark Pet Sanctuary.
- The expansion of our Emergency Safe Shelter by 3 rooms.
- The renewal of our Office on Violence Against Women funded Transitional Housing program, which includes expanded funding for survivors to improve their economic independence.
- The expansion of our development team.
- The increased capacity of our counseling team, reducing our waiting list for services.
- The record breaking 5,528 donations processed by our Thrift Store (a 13% increase over 2023).

Despite the successes of our clients and our organization, Peace at Home is mindful of the challenges that lie ahead. We are deeply concerned about the reduction of VOCA (Victims of Crime Act) funding. Along with other federal funding cuts, this poses a threat not only to our shelter, but to the entire victim services infrastructure.

The demand for our services remains high. From crisis calls to shelter requests, the number of survivors seeking help continues to grow. Families need our support now more than ever.

"We remain committed to providing a safe shelter and empowering services for survivors of domestic violence in 2025. With your continued support, we can ensure that the progress we have made this year will only strengthen our ability to save lives. Thank you for standing with us in this important work. Your generosity continues to change lives."

# **HANNAH'S STORY**

When Hannah reached out to Peace at Home in 2023, she didn't know where else to turn. She had left her abusive husband and had a home for herself and her son, but because her work status was tied to her husband's immigration status, she lost her job.

Hannah's son needed regular medical treatments and she wasn't sure how she could survive after leaving her husband without any income.

She turned to Peace at Home for help. The staff attorney and legal advocates at Peace at Home worked with Hannah to get her an order of protection and to restore her legal work status. The Legal Team also assisted her in obtaining custody of her child with child support in her divorce agreement.

In addition to legal support, Hannah and her son also received financial assistance for rent and utilities as well as clothing and household items.



Today, Hannah is able to work again and has her dream job. She was able to stay in her safe housing and her son has continued to receive his medical treatments. They are now safe and thriving, living free from violence.

Families in your community are breaking the cycle of violence every day. When you support Peace at Home, you provide the tools families need to escape abuse.
