These awards are given by Peace at Home Family Shelter to acknowledge the contributions of the individuals who best exemplify the Shelter's mission: to empower victims of domestic violence to survive and thrive.

2024 Courage Award Honoree: Judge Joanna Taylor



Judge Joanna Taylor serves as the 4th Judicial Circuit Court of Arkansas since her election in 2010. She actively participates in civic engagements, including the Single Parent Scholarship Fund of NWA, the Kiwanis Club, the Huntsville Community Choir, and the Friendship Club. Judge Taylor was instrumental in the creation of the Washington County Domestic Violence Specialty Court. This change eliminates the need for victims to repeat their experience in multiple hearings before different judges. With specialized training, Judge Taylor ensures consistency and prioritizes victim protection and family rehabilitation, displaying kindness, patience, and reasonableness throughout the process. Her work has made a significant impact on survivors in our community navigating the legal system.

2024 Courage Award Speaker: Dean Cynthia Nance

Cynthia Nance has been appointed as the permanent dean of the University of Arkansas School of Law and will serve until June 2026. This is not Nance's first time as dean, having previously held the position from 2006-2011. She has been part of the university for almost thirty years, having first joined the law school as an assistant professor in 1994. Dean Nance has many notable accomplishments, including being the first woman and person of color to serve as the dean of the law school since its creation in 1924. Her areas of expertise are labor and employment law, workplace legislation, poverty law, and Lawyers as Leaders. Additionally, she was the law school's first director of pro bono and community engagement. Dean Nance is also a passionate advocate for survivors of domestic violence in our community.
